### 1. Definitions

- a. **“Work”** means the copyrightable work of authorship offered under the terms of this License.
- b. **“Licensor” , “You”, or “The Creator”** means: the individual, individuals, entity or entities that offers the Work under the terms of this License.
- c. **“Licensee”** means: us, we, The Moholy Ground Project, or M.G.P.
- d. **“Original Author”** means the individual, individuals, entity or entities who created the Work.
- e. **“Derivative Work”** means: a work based upon the Work or upon the Work and other pre-existing works. Photographs of other art works
